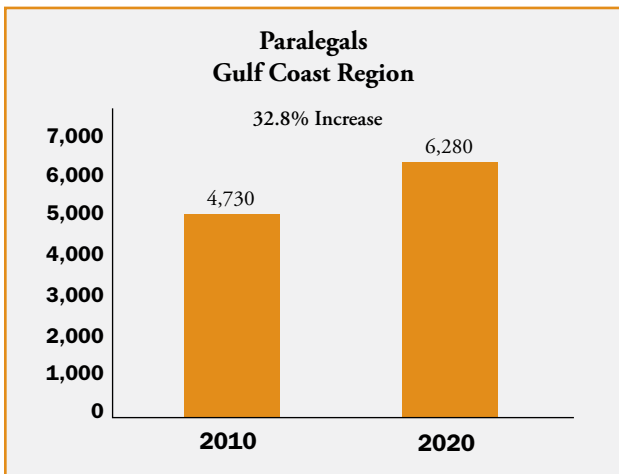
ALMOST EVERY INDUSTRY HAS A PLACE FOR PARALEGALS

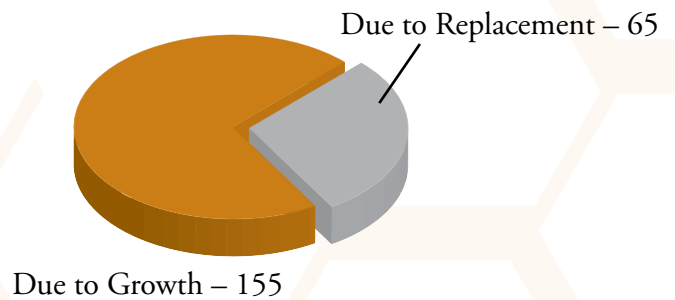

Annual Job Openings Gulf Coast Region

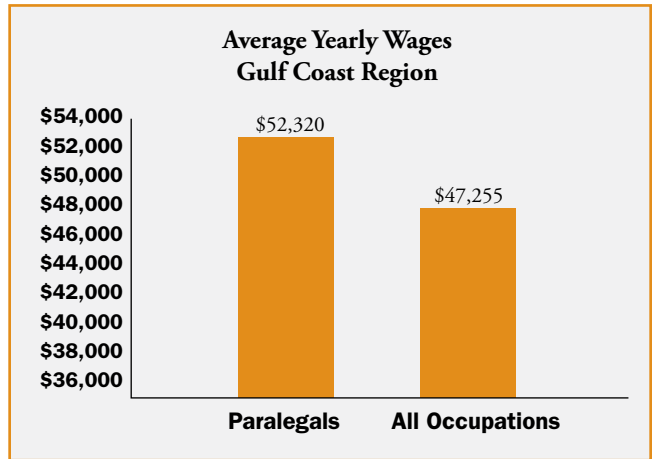

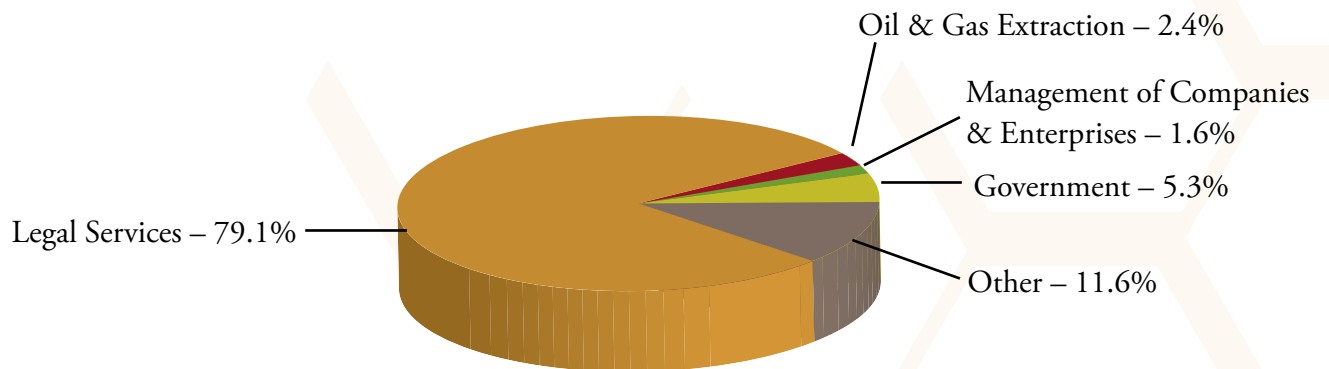

HOW DO YOU BECOME A PARALEGAL OR LEGAL ASSISTANT?

The most common entry into a career as a paralegal is through a community college program by obtaining an associate's degree. It is very beneficial to attend training that offers an internship that provides experience working in the legal environment.

Although most employers do not require certification, earning a certificate offers an advantage when competing for jobs. Many individuals that already have a college degree, or experience in a technical field useful to law firms, can complete a certification program.
