# Workforce Solutions' Maximum Reimbursement Rates

# Effective October 1, 2021

**REIMBURSEMENT RATES:** All vendors will be reimbursed for services rendered at the vendor's published rate up to the maximum reimbursement rate established by Workforce Solutions. Vendors will not be reimbursed at a rate higher than their published rate for the age of the child receiving childcare financial aid. Vendors will be reimbursed a blended rate for school-age children during the normal school year including school holidays and teacher in-service days. Vendors will be reimbursed for school-age children according to the referral during the summer months. The vendor may also receive a child specific inclusion assistance rate if authorized by Workforce Solutions. The allowable inclusion rate is 190% of Workforce Solutions reimbursement rate subject to the established maximum rates.
