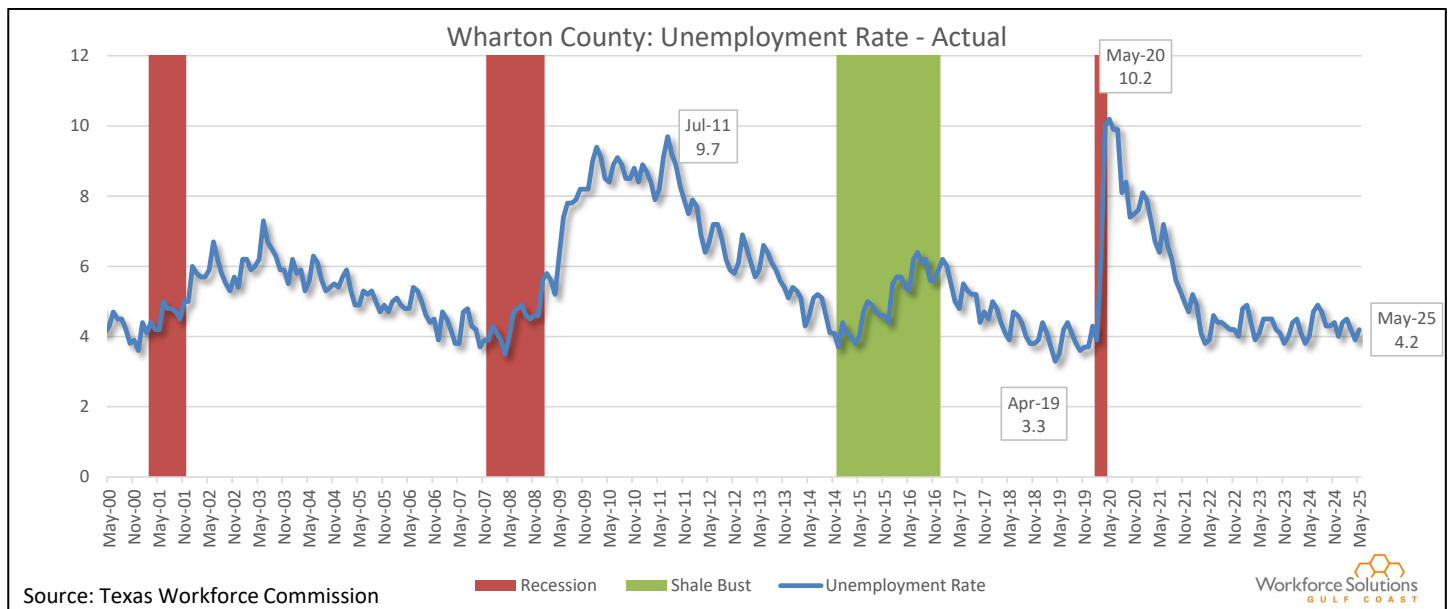

County Employment Data*

Wharton County's unemployment rate rose to 4.2% in May, up 0.3 percentage points from the prior month and 0.2 points higher than the same time last year. The county's unemployment rate remained slightly above both the state and national averages, which stood at 4.0%. In the fourth quarter of 2024, Wharton County added 265 jobs, a 1.6% increase—well above the county's historical fourth-quarter average of 0.4%. Eight of the eleven major industry sectors reported gains. The largest contributors to growth were Construction, +120 jobs (+17.8%), Manufacturing, +88 jobs (+6.2%), and Public Administration, +117 jobs (+4.3%), driven by Local Government, which added 124 jobs (+4.9%). The only significant loss occurred in Trade, Transportation, and Utilities, which declined by 101 jobs (-2.4%). According to Quarterly Census of Employment and Wages (QCEW) data from the Texas Workforce Commission, this decline was spread across Wholesale Trade, Retail Trade, and Utilities. On a year-over-year basis, Wharton County reported a job loss for the third consecutive quarter, with payrolls down 180 jobs (-1.1%) compared to Q4 2023. Six of the eleven major industry sectors recorded losses. The largest annual decline was in Trade, Transportation, and Utilities, -563 jobs (-12.2%). Three sectors posted substantial annual gains: Construction, +216 jobs (+37.3%), Manufacturing, +165 jobs (+12.3%), and Education and Health Services, +155 jobs (+6.6%). Employment is the estimate of employment based upon the sample, not the sample employment. Wages for the OES survey are straight-time, gross pay, exclusive of premium pay. Base rate, cost-of-living allowances, guaranteed pay, hazardous-duty pay, incentive pay including commissions and production bonuses, tips, and on-call pay are included. Excluded are back pay, jury duty pay, overtime pay, severance pay, shift differentials, nonproduction bonuses, employer cost of supplementary benefits, and tuition reimbursements. **The Gulf Coast Region is defined as Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties.
